CERTIFICATE OF INCORPORATION OF
~~THE~~ MOORISH SCIENCE TEMPLE OF AMERICA, INC.

Pursuant to Article 10 of the Religious Corporations Law

We, the undersigned, for the purpose of incorporating an unincorporated Moorish Science Temple church, pursuant to Article 10 of the Religious Corporations Law, hereby certify as follows:

1. A meeting of ~~THE~~ MOORISH SCIENCE TEMPLE OF AMERICA, ~~INC.~~, an unincorporated Moorish Science church, was duly called and held in conformity with Article 10 of the Religious Corporations Law at 1837 Strauss Street, Brooklyn, New York, on the 9th day of February, 1968, at which meeting a majority of the duly qualified voters of said church, being at least six in number, were present.

2. At said meeting JOSEPH JEFFRIES-EL, one of the subscribers hereto, was presiding officer, and ~~WILBERT CLARKE-BEY~~ and WILLIAM E. MURRAY-BEY, the other subscribers hereto, were present and voted thereat.

3. At said meeting it was duly decided that said church should become incorporated pursuant to Article 10 of the Religious Corporations Law.

4. The name of the proposed corporation shall be ~~THE~~ MOORISH SCIENCE TEMPLE OF AMERICA, INC. ~~XXX~~

5. The number of trustees thereof shall be six.

6. The names of the persons elected as trustees, and the terms of office for which they were respectively elected are as follows:

HENRY FULLER-BEY and RONALD SMITH-BEY
to hold office until the first annual election of trustees thereafter;

WILLIAM E. MURRAY-BEY and KENNETH DOUGLAS ALEX BEY
to hold office until the second annual election thereafter; and

JOSEPH JEFFRIES-EL and WILBERT CLARKE-BEY
to hold office until the third annual election thereafter.

7. The principal place of worship of said church is located in the City of New York, County of Kings and State of New York.

8. All of the subscribers of this certificate are persons of full age, at least two-thirds of them are citizens of the United States and one a resident of the State of New York.
